It is our understanding that the Libbey Items are purchased by Digital on Demand from Libbey, decorated or otherwise modified or altered by Digital on Demand and sold by Digital on Demand as decorated or otherwise modified or altered, to its Digital on Demand. Accordingly, Libbey is unable to certify the regulatory compliance of, or otherwise make representations regarding, this Item as ultimately sold to your Digital on Demand. Libbey is only able to certify compliance of or otherwise make representations regarding the Libbey Items as produced and sold by Libbey to Digital on Demand as of the time of shipping from Libbey's manufacturing facility or distribution center.

These Items consist of undecorated soda lime glass. Libbey has several manufacturing facilities, and Libbey's glass compositions vary slightly among facilities due to the availability of raw materials. However, the glass composition for all of our soda lime glass contains some or all of the following materials:

SiO₂ (silica dioxide)

Al₂O₃ (alumina, aluminum oxide)

Fe₂O₃ (iron oxide)

(lime, calcium oxide) CaO (magnesium oxide) MgO (sodium monoxide) Na₂O K_2O (potassium oxide) SO_3 (sulfur trioxide) TiO₂ (titanium dioxide) SrO (strontium oxide) ZrO_2 (zirconium dioxide)

Libbey does not intentionally add lead or cadmium to the raw materials used in manufacturing its undecorated soda lime glass tableware. Accordingly, our soda lime glass material is considered leadless, non-toxic, and non-radioactive.

Libbey is pleased to confirm that, to the best of our knowledge, as of the time and date of shipping from Libbey's manufacturing facility or distribution center, this Item meets all current applicable Federal and State standards for undecorated soda lime glass tableware, including but not necessarily limited to all applicable FDA Lead and Cadmium guidelines and California Proposition 65.

Any and all representations, warranties, and certifications contained herein apply only to the Libbey undecorated soda lime glass tableware Item, as produced and sold by Libbey to Digital on Demand as of the time of shipping from Libbey's manufacturing facility or distribution center.
